Bracing for Impact: Preparing for Hurricane Florence

With Florence right around the corner, farmers up and down the east coast are cringing at the thought as beautiful crops stand in the fields and fall calves are hitting the ground. As Thursday approaches, please take a moment to think about the essentials for your home and operation. Asking a few simple questions can get you off to a good start.

Wind

- What items will blow in heavy winds? What do I need to pick up, move, or tie down?

- Are there trees or limbs I need to trim?

- Do I have plenty of gas and chainsaw oil to deal with damage?

Flooding

- Are my pesticides stored in a safe place?

- What areas will flood? How will this impact my crops, livestock, or my ability to get around and complete necessary chores?

- Is my pond overflow pipe unclogged? Is my pond prepared for excess water?

- Are my animals somewhere that they could be trapped if there is flooding?

- Do I have trailers and trucks ready if I or my neighbors need assistance moving livestock, items, or their families out of dangerous areas? IN THIS ISSUE

Unwanted Pesticides Pick-Up Program

After budget restraints last year, the Virginia Ag Pesticide Collection Program is back, and this year, it is right here at home in Southside Virginia! The Virginia Department of Agriculture & Consumer Services has arranged for the pick up of outdated and unwanted pesticides at a number of locations in the coming weeks. This program is designed to help agricultural producers remove extra or unidentified pesticides from their property in a safe, legal manner. This program is FREE, but due to the nature of working with chemicals, VDACS asks producers to please register ahead of time so that they will have the equipment needed to handle everything that is collected.

Private pesticide license recertification courses coming soon!

It is almost pesticide recertification time, and we promise we haven't forgotten! Your extension agent will be sending out his or her letter with local recertification opportunities in the coming months. Be patient. We have to organize dates around a lot of events, and it takes us a little time to get the full letter of dates together. You may receive a letter from VDACS prior to ours, but it will be coming soon.

A few reminders:

* If your license is set to expire December 31, 2018 but you know you have banked credits, don't worry. VDACS will not issue you a new license until just before the one in your pocket is set to expire - not right after you take your extra recert. course.

*There is a grace period until the end of February following your expiration date. During this time, you may not purchase restricted use chemicals, BUT if you recertify in this grace period, you will not have to retest.
